



Review Of Cost-Sharing Case** (July 22, 2019): Chipmaker Altera Corp. on Monday asked all Ninth Circuit judges to rehear a case in which a 2-1 majority found that the Internal Revenue Service was justified in requiring related business entities to include stock-based compensation in their cost-sharing agreements.
- Purdue Wants Fed. Circ. To Rehear OxyContin Patent Claims** (July 22, 2019): Prescription opioid maker Purdue Pharma asked the full Federal Circuit to reconsider an opinion upholding a Patent Trial and Appeal Board decision invalidating claims in a patent covering abuse-deterrent formulations of extended-release OxyContin.






