TTAB Cases

With **TTAB Cases**, you can search existing cases and set up alerts for new cases.

Customize your search by keyword, case number, registration number, serial number, mark, party name, correspondence info, case type, status, or industry, and click **Search**.

You can filter results by case filing date, case type, latest doc type, plaintiff, defendant, or status.

Keyword searches include the full text of underlying case documents*, for even more flexibility and accuracy in your searches.

**Full-text PDF search covers all TTAB documents filed since January 2017, plus select documents filed prior to 2017 in high-profile TTAB cases.*
