## **RE: Unemployment Insurance Benefits for Misclassified Workers**

Dear Governor Newsom, Secretary Su and Director Hilliard,

I respectfully urge the Employment Development Department (EDD) to immediately provide Unemployment Insurance benefits to workers misclassified under California's ABC test. This will help ensure all workers who are filing claims have access to California's safety net in this time of economic uncertainty and hardship.

The economic impact of the COVID-19 pandemic will be severe and far-reaching, and EDD is on the front lines in combatting economic harm. Based on initial reports on layoffs over the last few weeks, the task before EDD is monumental. I am hopeful that the Legislature and the Administration will do everything possible to ensure that EDD receives the resources it needs to rise to this challenge.

It is imperative that EDD seriously address the misclassification of gig economy workers. Recent press reports about the emerging economic crisis have highlighted how independent contractors and gig economy workers may miss crucial safety net benefits such as unemployment insurance.<sup>1</sup> However, this does not need to be the case here in California: As a result of the *Dynamex* decision and AB 5 of 2019, these individuals may be considered employees under the ABC test and thus eligible for unemployment insurance. There is no reason to wait to enforce the ABC test.
