COMPLAINT

Plaintiffs Gateway Grill, Inc., Kevin E. McFadden and Michael Barrett, by their undersigned counsel, file this Complaint against Defendant Brittney M. Davenport, averring as follows:

PARTIES

1. Plaintiff Gateway Grill, Inc. ("Gateway Grill") is a corporation organized and existing under the laws of the Commonwealth of Pennsylvania with its principal place of business located at 4251 Northern Pike, Monroeville, Pennsylvania 15146.

2. Plaintiff Kevin E. McFadden ("McFadden") is an adult individual and resident of the Commonwealth of Pennsylvania. McFadden is the sole owner and President of the Gateway Grill.

3. Plaintiff Michael Barrett ("Barrett") is an adult individual and resident of the Commonwealth of Pennsylvania. Barrett is the General Manager of the Gateway Grill's restaurant.

4. Defendant Brittney M. Davenport ("Davenport") is an adult individual and resident of the Commonwealth of Pennsylvania, residing at, upon information and belief, 1250 Renton Road, Plum Borough, Pennsylvania 15239.

FACTUAL BACKGROUND

5. Since 2000, the Gateway Grill has operated a popular American grill and sports bar (the "Restaurant") at its location in Monroeville, at which it currently employs approximately 60 full and part-time employees.

6. For parts of approximately 6 years, Gateway employed Davenport as a dine-in table server and tipped employee at its Restaurant, and she was paid the cash minimum wage (\$2.83 per hour) plus customer tips.

7. On March 6, 2020, Governor Tom Wolf issued a Proclamation of Disaster Emergency as a result of the COVID-19 virus.

8. On March 19, 2020, Governor Wolf issued an Order requiring all non-life sustaining businesses in the Commonwealth, including restaurants and bars, to cease operation and close all physical locations, which was extended by further Order dated April 1, 2020.

9. Under Governor Wolf's Orders, all restaurants and bars were ordered to close their dine-in facilities, and Gateway Grill was limited to carry-out, curbside pick-up, and delivery.

10. The closure of dine-in facilities was only recently partially lifted when Allegheny County was transitioned to the Green Phase on June 5, 2020.

11. As a result of the COVID-19 Orders and the loss of customers caused by the mandatory closure of the Restaurant's dine-in operations, and to assist its employees, the Gateway Grill raised all table servers' pay (including Davenport) to the standard minimum wage of \$7.25 per hour plus a share of tips for carry-out, curbside pick-up and delivery services.

12. On or around May 21, 2020, it was brought to the Gateway Grill's attention that, due to a clerical error through its payroll processor, Automatic Data Processing, Inc. ("ADP"), paychecks issued to certain servers reflected the pre-COVID-19 \$2.83 per hour cash minimum wage as opposed to the newly- implemented \$7.25 standard minimum wage.

13. The Gateway Grill and ADP immediately corrected the error and issued new paychecks to the affected employees.

14. For inexplicable reasons, Davenport seized upon the clerical error and commenced a widespread online campaign designed to defame and disparage the Gateway Grill, McFadden and Barrett, and maliciously destroy their business and professional reputations.

15. Beginning in at least May 2020, Davenport published false, defamatory and disparaging statements concerning the Gateway Grill, McFadden and Barrett on Facebook pages maintained by, among others, Davenport, the Gateway Grill and the Plum Community. (Copies of specific examples of the false, disparaging and defamatory postings published by Davenport are collectively attached as Exhibit 1.)

16. Specifically, in May and June 2020, Davenport intentionally published numerous false, defamatory and disparaging statements concerning the Gateway Grill, McFadden and Barrett, falsely stating, among other things, that they: (a) engaged in corrupt practices; (b) committed tax fraud; (c) committed tip misappropriation; (d) were underpaying employees; (e) refused to issue paychecks to employees; and (f) engaged in unsafe procedures during the COVID-19 pandemic. (Ex. 1.)

17. Davenport also intentionally published numerous false, defamatory and disparaging statements concerning the Gateway Grill, McFadden and Barrett by painting false statements on the windows of her vehicle declaring that the Gateway Grill, McFadden and Barrett

have engaged in discrimination, tax fraud and tip misappropriation, photographs of which Davenport posted to various Facebook pages. (Copies of the Facebook postings containing photographs of Davenport's vehicle are collectively attached as Exhibit 2.)

18. Shortly after May 22, 2020, after learning of Davenport's publication of the false, defamatory and disparaging statements, the Gateway Grill terminated Davenport's employment.

19. Since her termination, Davenport has continued to publish false, defamatory and disparaging statements concerning the Gateway Grill, McFadden and Barrett on various Facebook pages and otherwise, which false statements have been republished by numerous third parties.

20. In addition, on May 26, 2020, Davenport appeared at the Gateway Grill's premises with her husband Gregory Davenport and an acquaintance known as "Jason" to "ambush" and verbally and physically threaten McFadden and Barrett, which resulted in an employee of the Gateway Grill having to place an emergency call to the Monroeville Police Department. (*See* Ex. 1.)

21. Davenport's false, defamatory and disparaging statements are intended to attack the business and professional reputations of the Gateway Grill, McFadden and Barrett, and are maliciously designed to harm the Gateway Grill's business.

22. Davenport's false, defamatory and disparaging statements have caused harm and irreparable damage to the Restaurant's goodwill and customer and employee relationships. (*See* Ex. 1.)

23. Davenport's false, defamatory and disparaging statements have injured the Gateway Grill, McFadden and Barrett in their business and professional reputations so as to lower them in the estimation of customers and potential customers, and deterred third persons, including, without limitation, potential new employees, from dealing with them.

injunctive relief, interest and costs, and all such additional relief that the Court deems necessary and proper.

<u>COUNT II – DEFAMATION</u> (GATEWAY GRILL, McFADDEN AND BARRETT V. DAVENPORT)

32. The averments of paragraphs 1 through 31 are incorporated by reference as if fully set forth herein.

33. As averred herein, the statements published by Davenport are baseless, wholly false and defamatory.

34. The false and defamatory statements made by Davenport apply to the Gateway Grill, McFadden and Barrett, and were published to numerous third parties, without privilege.

35. The false and defamatory statements made by Davenport and published to numerous third parties, were further republished to additional third parties, without privilege.

36. The false and defamatory statements published by Davenport involve words directly accusing the Gateway Grill, McFadden and Barrett of business and professional misconduct.

37. The false and defamatory statements published by Davenport ascribe to the Gateway Grill, McFadden and Barrett conduct and character that would adversely affect their fitness for the proper conduct of their business, trade and profession.

38. The statements published by Davenport concerning the Gateway Grill, McFadden and Barrett are false and defamatory in character and constitute defamation per se as they are statements that impute business misconduct.

39. The false and defamatory statements published by Davenport were made with actual malice because she acted with knowledge that her statements were false.

40. The false and defamatory statements published by Davenport concerning the Gateway Grill, McFadden and Barrett have impaired their business, professional and personal reputations and standing in the community, and deterred third persons from associating or dealing with them.

41. As a direct and proximate result of Davenport's publication of the false and defamatory statements, the Gateway Grill, McFadden and Barrett have sustained actual harm, including, without limitation, injury to their business, professional and personal reputations and standing in the community, as well as humiliation, emotional distress, mental anguish and suffering.

42. Davenport's conduct was malicious, outrageous, willful and oppressive because of her vengeful personal motive and/or reckless indifference to the Gateway Grill, McFadden and Barrett's rights.

WHEREFORE, the Gateway Grill, McFadden and Barrett demand judgment in their favor and against Davenport for damages in an amount in excess of the jurisdictional limits of this Court, punitive damages, injunctive relief, interest and costs, and all such additional relief that the Court deems necessary and proper.

<u>COUNT III -TORTIOUS INTEFERENCE WITH EXISTING AND PROSPECTIVE</u> <u>CONTRACTUAL AND BUSINESS RELATIONSHIPS</u> (GATEWAY GRILL V. DAVENPORT)

43. The averments of paragraphs 1 through 42 are incorporated by reference as if fully set forth herein.

44. The Gateway Grill has existing and prospective contractual and business relationships with its employees, potential employees, customers, potential customers, and the community at large.

45. As averred herein, without justification or privilege, Davenport has engaged in a campaign of purposeful acts specifically intended to harm the Gateway Grill's existing contractual and business relationships with its current employees, customers, and others.

46. As averred herein, without justification or privilege, Davenport has engaged in a campaign of purposeful acts specifically intended to harm the Gateway Grill's prospective contractual and business relationships with potential new employees, customers and others.

47. As a direct and proximate result of Davenport's unlawful conduct, the Gateway Grill has sustained actual harm, including, without limitation, injury to its goodwill, business reputation and standing in the community.

48. Davenport's conduct was malicious, outrageous, willful and oppressive because of her vengeful personal motive and/or reckless indifference to the Gateway Grill's rights.

WHEREFORE, the Gateway Grill demands judgment in its favor and against Davenport for damages in an amount in excess of the jurisdictional limits of this Court, punitive damages, injunctive relief, interest and costs, and all such additional relief that the Court deems necessary and proper.

If any of you have ever waitress before you know that you don't really ever get a pay check. You get paid \$2.83 per hour and you claim your tips. Gateway Grill had told their waitress not to claim their tips because some of the waitress weren't claiming enough so they would make sure they were claiming enough. Waitress typically claim all charge card tips and usually about 10% of their cash tips. Please remember a waitress doesn't walk out w your full 10-20% tip you leave them. In most cases They have to tip out the bartender, busboy etc. Their \$2.83 wage covers the amount they are taxed on your tips so they usually got a void check so most waitress never pay any attention to their paystubs. When Brit went back thru her old pay stubs she realized they where claiming WAY more then she actually made ... in some cases double! The more she looked into this the more she found out what they were doing not only to her but to many if not all of the other waitress. During covid they were suppose to be making \$7.25 per hour and splitting what ever to-go tips among all the employees working.. including the cooks which she had no problem with. The problem was they lowered their wage from \$7.25 to \$2.83 and never told any off them and even thou cooks were receiving a portion of the tips management never reported that income on the cooks paychecks and claimed all of the money (which got taxed) onto the waitress. So once again they where claiming they made more tips then they actually did and they were/are paying the taxes on money that other employees received. Today my daughter walked into Gateway Grill with her head held high and confronted management. Today my daughter was fired for standing up for herself and all of the other waitress. Today my daughter left behind all of her regulars that she loved waiting on so much and left behind a job that she worked her as* off and made good money. Today just like every other day my daughter made me extremely proud to call her my daughter.
