- Called Gina Mele at approx 1236 for follow up per Agro and Chief Fahey. When asked about her condition she stated she was sore, had back pain and arm tenderness. When asked about her husbands condition she stated that he went to Kenmore Mercy for treatment, that he was given an IV and antibiotics for the bite, was x-rayed for possible rotator cuff injury and that he sustained an interior orbit fracture to his eye. They did have discharge paperwork documenting the injuries.

- Mele also complained about a secong incident involving Maria Grisanti and her son on 6/23 in which a vehicle was parked improperly and Mele was given the finger by both Maria Grisanti and her son.

- Mele expressed disapproval over the fact that no arrest was made on the night of incident. I did explain to her that everything needed to be collected, investigated, and reviewed before any arrest/s would be made.

- Did speak with PO Gehr in regards to conduct of the Grisantis upon initial arrival on scene. Gehr did states that once on scene the females involved were still arguing and screaming at each other. Once parties were separated he attemted to speak with the Mele's. During conversation Maria Grisanti continued to yell and scream and did trie to approach. At that point it was decided that Maria Grisanti would be placed in the back of a patrol vehicle to try and calm the situation. Maria Grisant did attempt to pull away from officers at which point she was taken to the ground and cuffed. During the cuffing process Mark Grisanti grabbed/touched PO Gehr on the shoulder stating that he did not have to treat his wife that way. I just had a quick few items/requests that I wanted to send over to you in follow up to the above incident.

As mentioned on the night of the incident, I wish to make clear that my husband and I still wish to press assault charges against Mark and Maria Grisanti. As you know, Maria caused bodily injury to my husband which included a vicious bite to his arm which broke skin, a fractured bone under his eye, and a shoulder injury which all resulted in having to be seen in the emergency room. Due to my husband's health history of cancer and current autoimmune condition, my husband had to be given an IV of antibiotics and a prescription of antibiotics to avoid a serious infection that could have been caused by Maria Grisanti's saliva entering my husband's bloodstream. Also, in the time of the global pandemic COVID-19 my husband was put in even more grave danger from this injury. I would think that charges would be more than reasonable including harassment, trespassing and assault. Per conversations with you and with D District, we are unable to do so and that the DA is investigating.

Per a previous phone conversation we had, I wanted to bring attention again to the possibility of additional footage that could have been captured by Mark Grisanti's Ring doorbell. I know I have been told that their free-trial ended but would like that to be further looked into and verified. Additionally, I wanted to remind you that the Chwalinski residence at **property** is also surveilled with cameras in two different front windows with clear view of my property so hopefully access to that footage will be available.

I also am concerned about the credibility of the witnesses who have made themselves available to you. As you mentioned, none of the witnesses whom you spoke with saw the entire incident. Additionally, these witnesses are close friends of the Grisanti's and they all frequently socialize together and with their families. It seems that these accounts would inevitably be biased.

I have also grown frustrated with the lack of clear communication and being bounced back and forth between BPD and the District's Attorney's office. I have requested copies of the statements from the incident. I was told by BPD that the DA's office would have no problem providing them to me; however, when I called the DA's office and spoke with Danielle D'Abate I was told otherwise. She stated that I could not have access to the statements, and went as far to say that she could not speak with me at all due to the pending investigation and said I had to ask BPD for the statements again. Do you have access to these statements? I would like copies at your soonest convenience.

In conclusion to the above mentioned, I am really concerned that mind and my husband's civil rights are being violated. I know that you have mentioned that you are "dealing with higher ups" and " man of power," but I would hope that Mark Grisanti's position as a Judge would not be infringing upon our rights as we're entitled to equal protection under the law. As you can imagine, my frustration is growing with the run-around and lack of action and it is an overwhelming feeling of injustice.

I hope that you understand my concerns. Thank you for your time.
