## PLAINTIFF JOHN GALVAN'S MOTION TO DISMISS WITHOUT PREJUDICE

Plaintiff John Galvan moves to voluntarily dismiss his individual claims without prejudice pursuant to Federal Rule of Civil Procedure 41(a), stating in support as follows:

- 1. Mr. Galvan and Mr. Taylor filed this lawsuit on July 31, 2020 to cause Defendants to issue the Economic Impact Payments to which the Plaintiffs were entitled by law.
- 2. The IRS made an Economic Impact Payment on Mr. Taylor's behalf after the complaint was filed.<sup>1</sup>
- 3. Accordingly, the Court dismissed Mr. Taylor without prejudice as a party plaintiff on October 15, 2020.<sup>2</sup>
